FACILITIES POLICY

1.1.0. Use of the interior of Courthouse Complex Facilities:

It shall be the policy of the DeKalb County Board that all non-governmental use of the interior of the buildings in the Courthouse Complex shall be discontinued effective with the adoption of this policy.

2.1.0. Use of the exterior facilities of the Courthouse Complex:

2.1.1. It shall be the policy of the DeKalb County Board that all non-governmental use, including signs, of the exterior facilities of the Courthouse Complex, including grounds and parking lots, shall be discontinued effective with the date of adoption of this policy.

2.2.1. Those groups currently utilizing the exterior facilities of the Courthouse Complex shall be allowed to continue with the written consent of the DeKalb County Public Building Commission. Specifically, those groups are; Sycamore Lions Club for utilization during the one week period of the annual Sycamore Pumpkin Festival; the Kishwaukee Valley Art League for one weekend in June to conduct the annual Art Festival; and the VietNow Organization on the evening preceding each Veteran's Day to conduct an overnight vigil.

2.2.2. Those groups utilizing the exterior facilities complex named above will be required to enter into written agreements with the County and shall assume all liability for damage to persons and/or property.

3.1.0. Flying of Flags

3.2.0. The U.S. Flag will be flown continuously at the DeKalb County Courthouse.
