That study resulted in the following fee increases, as passed by the DeKalb County Board on Nov. 15<sup>th</sup>, 2000, as authorized by Chapter 34 -- Section 5001 of Illinois Revised Statutes. Therefore, effective January 1, 2001 the DeKalb County Sheriff's fees for Civil Process matters will be as follows: \* This is the first civil process fee increase since 1992.

In 2016 DeKalb County Government retained the firm of Fiscal Choice Consulting, LLC to determine the cost of fee services in the Sheriff's Office and County Clerk/Recorder. These offices are statutorily eligible for changes of prices based on an independent cost study. That study resulted in the following fee increases, as passed by the DeKalb County Board on November 16, 2016, in Resolution R-2016-80. This is the first Civil Process Fee increase since 2001. Therefore, effective January 1, 2017 the DeKalb County Sheriff's fees for Civil Process matters will be as follows:

**EVICTIONS** - Sheriff's Fee for acting upon/completing "Evictions" will be \$184.00 total (if the Eviction is cancelled then we only charge the Posting Fee, which is the same as Total Service Fee to that Town).
