Annual Summary 2016

The DeKalb County Community Mental Health Board (DCCMHB) faced the challenges and opportunities of 2016 with a strong commitment to behavioral healthcare. The biggest challenge was the lack of a state budget and the impact on funded agencies. A stopgap budget was implemented in July 2016 but expired in December 2016 leaving many agencies unsure about their fiscal year 2017 budgets. The DCCMHB was able to assist agencies during this time, through advanced funding, emergency funding, support, and advocacy.

The grant year 2017 grant application cycle started in January 2016. Seven agencies new to the DCCMHB applied for funds with four receiving funding. As anticipated, there was also an increase in requested amounts from currently funded agencies. It was a highly competitive grant year with requests exceeding funds available by \$733,400.

The DCCMHB continued in 2016 to support the residents of Fairdale and the DeKalb County Long Term Recovery Corporation as they worked to recover from the E4 tornado that decimated the town of Fairdale on April 9, 2015. The Board expended nearly \$25,000 in emergency funds to ensure that those affected by the tornado received emotional and mental health supports. The Board was instrumental in planning and participating in Fairdale: Year of New Beginnings, a memorial event held on the one year anniversary of the tornado.

The work of the DeKalb County Mental Health Coordinating Council (MHCC) continued. The MHCC identified priority areas and developed action committees to address those priorities. The priority areas identified are 1) Explore and develop additional mental health programming including Psychiatry, Intensive Outpatient Mental Health Services, Triage center, and Crisis Intervention Beds. 2) Exploration of supportive and supervised housing opportunities within DeKalb County. 3) Prevention/Education/Referral through exploration and implementation of a 211 call system. The Mental Health Service Committee was initiated to address the first priority, an introductory meeting occurred May 19, 2016, and a strategic planning process was started. A second meeting facilitated by Dr. Tim Brown, Psy.D., occurred on October 6, 2016. The Committee started to identify the target populations with unmet needs. Stakeholders will collect data to support identification of the populations. The committee will create a "Mental Health Intervention Resource Guide" for law enforcement, ER staff, and jail personnel to share with individuals and families. The Supportive Housing Action Committee met for the first time on October 19, 2016 and discussed housing options. The committee is considering hiring a consultant to identify gaps and possible solutions in meeting the needs of people with mental illness. For the third priority, in partnership with Kishwaukee United Way, 211 is advancing in DeKalb County with a projected launch date in March 2017.

The DCCMHB has entered into a partnership with Dr. Alicia Schatteman, School of Public & Global Affairs, Department of Public Administration and the Center for NGO Leadership and Development on a Performance Measurement Project. On April 28, 2016

Dr. Schatteman conducted a workshop for all DCCMHB funded agencies on Government and Nonprofit Performance Management. Three agencies were selected to work with Dr. Schatteman to develop and operationalize performance measurement outcomes. The goal is for agencies to develop their own performance measurements and utilize that information to highlight community impact and help attract funders. The three agencies selected to participate in the pilot study are the DeKalb County Youth Services Bureau, the DeKalb County Drug Court, and Family Service Agency. The Pilot Study is in Phase 2 and a report was generated by Dr. Schatteman highlighting the needs of the three agencies around outcomes/performance measurement development. The report was detailed and produced a number of philosophical issues the Board will need to address.

The DCCMHB hosted Mental Health First Aid training. With financial support from County Administration, DeKalb County Sheriff's Department, DeKalb County Court Services, and the DCCMHB, three Mental Health First Aid trainings and two Mental Health First Aid for Law Enforcement trainings were offered to DeKalb County employees, municipal police departments and local nonprofit providers. A total of 131 individuals received training, including 102 DeKalb County employees of which 35 were DeKalb County Sheriff's Department employees.

The DCCMHB is partnering with the DeKalb County Juvenile Justice Council to provide Trauma Informed training to stakeholders in DeKalb County. Invited attendees will include teachers, law enforcement, providers, and any interested professionals. A trauma informed care committee has been created to usher in the training. Trainings are planned for spring 2017.

The DCCMHB is committed to the mission of "Through leadership and funding the DCCMHB supports access to high quality behavioral healthcare services for DeKalb County residents". With no state budget in sight and uncertainty on the Federal level around the Affordable Care Act, the DCCMHB remains a stable source of funding and a resource to behavioral healthcare agencies throughout DeKalb County.




Grant Year 2016 Funding Allocations by Type of Service
