PLANNING & ZONING COMMITTEE

- a. PUBLIC HEARING: PDF Cable television service is provided in unincorporated DeKalb County under franchises granted by the County Board. Each company that wishes to provide cable TV service must be granted a franchise following an application for approval. CMN-RUS, INC is requesting approval of a franchise to provide cable TV service to residence in unincorporated DeKalb and Sycamore Townships. Before approval of a new franchise can be granted, the application must be reviewed by a Committee of the County Board and subject to a public hearing.
- b. Ordinance O2019-26: PDF An Ordinance Granting a Cable Franchise to CMN-RUS, Inc. The DeKalb County Board hereby approves the provided Cable Television Franchise Agreement with Metronet (CMN-RUS, Inc.) effective immediately.
