HEARING NOTICE ADDENDUM

- **PRIOR to the scheduled hearing**, the appellant/taxpayer, board of review and intervenor (if any) are permitted and encouraged to contact each other to determine if a settlement can be reached. (PTAB rule §1910.72)
- If a settlement is reached, the scheduled hearing will be canceled when the parties notify the Property Tax Appeal Board (PTAB) and provide a copy of the signed agreement prior to the hearing date.
- The hearing cannot be postponed without good cause/reason submitted in writing to the PTAB. (PTAB rule §1910.67(i))
- Failure of the appellant/taxpayer to appear will be cause to dismiss the appeal. (PTAB rule §1910.69(b))
- Board of review and/or intervenor will be defaulted for failure to appear. (PTAB rule §1910.69(b))
- When the appellant/taxpayer seeks a change of \$100,000 or more in assessed valuation, the appellant/taxpayer must provide a court reporter at his/her own expense for the hearing. (PTAB rule §1910.98)
- If your argument is based on an appraisal, you must have the appraiser present to testify. (PTAB rule §1910.67(l))
