- a. **Ordinance O2016-05:** Approving a Zoning Map Amendment for 9970 Keslinger Road in Afton Township. *The DeKalb County Board does hereby approve a Zoning Map Amendment to change the zoning of property located at 9970 Keslinger Road from PD-C, Planned Development-Commercial to PD-I, Planned Development-Industrial. DeKalb County controls the use of land outside of the city limits by its zoning regulations. Occasionally, the County amends the Zoning Ordinance to reflect changes in land use policy from the County Board, to better help implement the goals and objectives of the County-wide Comprehensive Plan, and to address omissions, ambiguities, and inconsistencies in the zoning regulations. DeKalb County is now proposing several such amendments to the text of its Zoning Ordinance. Before amendments to the Zoning Ordinance can be approved by the County Board, a public hearing must be held by the DeKalb County Hearing Officer.

The DeKalb County Planning, Zoning, and Building Department, on behalf of and under the direction of the Planning and Zoning Committee of the DeKalb County Board, has filed an application for several Zoning Text Amendments. **The required public hearing will be held by the Zoning Hearing Officer on Thursday, June 16, 2016, at 1:30 p.m. in the DeKalb County Administration Building, Conference Room East, 110 E. Sycamore Street, Sycamore, IL 60178.** All interested persons are encouraged to attend and be heard, as this will be the only opportunity for public input on this zoning application. The petition, DC-16-04, is available for inspection at the DeKalb County Planning Department, 110 East Sycamore Street, Sycamore, IL 60178 (815) 895-7188. The complete text of the proposed amendments to DeKalb County Zoning Ordinance may be viewed at the DeKalb County website, www.dekalbcounty.org under "Hot Topics."

Among the changes being proposed for the DeKalb County Zoning Ordinance are: amend the definition of "agriculture" to include farm dwellings and private stables; add a definition for "agriculturally-related" use and add "agriculturally-related, non-residential planned development" to the list of Special Uses in the A-1 District; and eliminate redundant permitted and special uses in the A-1 District that are included in the definition of "agriculture". There are other, more minor changes proposed to the Zoning Ordinance. Summaries of these proposed changes are available at the DeKalb County Planning and Zoning Department. Questions related to the proposed changes to the Zoning Ordinance may be directed to the Planning and Zoning staff.

The application for Zoning Text Amendment has been filed in accordance with the requirements of Section 10.04 of the DeKalb County Zoning Ordinance.
