**DEKALB COUNTY BOARD**  
**Executive Session Minutes**


**COLLECTIVE BARGAINING AS PROVIDED FOR IN 5 ILCS 120/2(C)(2)**

As per County Board Rules: *"Labor contracts are to be negotiated and recommended by the County Administrator to the County Board for the Board's final approval. Before negotiations begin, the County Administrator shall gather input from the Executive Committee and then the County Administrator, Board Chair, and Board Vice-Chair shall establish negotiation parameters and strategy. Labor disputes and policy interpretations arising above the departmental level will be handled by the County Administrator."*

Mr. Hanson informed the Committee that the Sheriff's MAP agreement was ending December 20, 2018. As per the rules, he wanted to gather strategy input from the Executive Committee.

Chairman Pietrowski noted that Board Members could contact Mr. Hanson, Vice-Chair Frieders, or himself in regards to anything they think should be negotiated into the next MAP Agreement.

**Ms. Little moved to adjourn the Executive Session and return to the Open Meeting at 8:12 p.m. Mr. Bagby seconded the motion. The motion was carried with a 9-0-0 roll call vote.
