**ORDINANCE FP-O2023-01
AN ORDINANCE OF THE DEKALB COUNTY FOREST PRESERVE DISTRICT
PROVIDING A TAX LEVY 2023 for FY 2024**

BE IT ORDAINED BY THE DEKALB COUNTY FOREST PRESERVE DISTRICT COMMISSIONERS:

Section 1. That there be and there is hereby levied upon all of the taxable property within the corporate limits of said DeKalb County Forest Preserve District subject to taxation for the year, 2023 A.D. the total sum of One Million Five Hundred, Seventy-Six Thousand Dollars (\$1,576,000) for the following specific purposes, and in the following respective sums, to-wit:

Environmental Education	50,000

GENERAL FUND: \$1,576 ,000

Section 2. That there be and there is hereby levied upon all of the taxable property within the corporate limits of said DeKalb County Forest Preserve District subject to taxation for the year 2023 A.D., the total sum of Two Hundred Sixty - Two Thousand Dollars (\$262,000) for the following respective sums, to wit:

TORT/ SAFETY / LIABILITY \$262,000

Section 3. That there be and there is hereby levied upon all of the taxable property within the corporate limits of said DeKalb County Forest Preserve District subject to taxation for the year 2023 A.D., the total sum of Six Thousand Dollars (\$6,000.00) for the following respective sums, to wit:

IMRF \$6,000

Section 4. That there be and there is hereby levied upon all of the taxable property within the corporate limits of said DeKalb County Forest Preserve District subject to taxation for the year 2023 A.D., the total sum of Fifty Two Thousand Dollars (\$52,000) for the following respective sums, to wit:

Social Security (F.I.C.A.) \$52,000

Total \$1,896,000


Section 5. That the Secretary of said DeKalb County Forest Preserve District is directed to file with the County Clerk of said County, a duly certified copy of this Ordinance.

Section 6. That this Ordinance shall be in full force and effect after its passage and approval as provided by law.



