**DEKALB COUNTY FOREST PRESERVE
DISTRICT PROCEEDINGS
December 13, 2023**

The DeKalb County Forest Preserve District Commissioners met in regular session at the Legislative Center's Gathertorium on Wednesday, December 13, 2023 at 8:43 p.m. President Willis called the meeting to order, and the Secretary called the roll. Ordinance FP-O2023-01: An Ordinance of the DeKalb County Forest Preserve District Providing for Tax Levy 2023 for FY2024

Motion

Plote moved that the DeKalb County Forest Preserve District Commissioners hereby approves to levy upon all the taxable property within DeKalb County, as assessed, for the calendar year beginning January 1, 2023, and ending December 31, 2023, and to be collected for the fiscal year beginning January 1, 2024, and ending December 31, 2024, in the total amount of \$1,896,000. Porterfield seconded the motion as presented.

Ordinance FP-O2023-02: An Ordinance of the DeKalb County Forest Preserve District Providing an Annual Appropriation

Motion

Plote moved that the DeKalb County Forest Preserve District Commissioners hereby approve that the monies received by the County Treasurer from taxes and other revenues, for the use of the Forest Preserve District during the Fiscal Year starting January 1, 2024, and ending December 31, 2024, are hereby appropriated as set forth in the attached for the purposes necessary for the DeKalb County Forest Preserve District to carry out its responsibilities. Mann-Lamb seconded the motion.

Resolution FP-R2023-015: A Resolution to Include the G2K Trail Schelkopf Easement Access and Tile Maintenance

Plote moved that the DeKalb County Forest Preserve District Commissioners hereby authorizes the District President to execute certain Access and Tile Easements, in form substantially conforming to the attached Exhibits "1" and "2," to current property owner Michael Schelkopf upon his conveyance of the 3.47 acres of the Hunter Road property which is the subject of the aforesaid Real Estate Sale Agreement to the District. Little seconded the motion.

Superintendent Hannan provided the Commissioners with a couple of brief updates on events that the Forest Preserve District offers.


ADJOURNMENT
